









# Press release: Memorandum of Understanding implement rail services between Verona and Herne developing respective networks

Munich, 10-05-2017

On Wednesday 10/05/2017 in Munich, -Consorzio ZAI Interporto Quadrante Europa, represented by President Matteo Gasparato, Quadrante Servizi S.r.l. represented by President Elio Nicito, Wanne-Herner Eisenbahn und Hafen GmbH (WHE) represented by Managing Director Christian Theis, CTH Container Terminal Herne GmbH represented by Managing Director Patrick A. Wisotzky and TX Logistik AG represented by CFO Pietro Mancuso signed a Memorandum of Understanding agreeing upon actions leading to the implementation of rail services between Verona and Herne developing respective networks

# The Agreement

The Signers deliberate a series of planning, administrative and promotional initiatives leading to concrete proposals for the coordinated planning for the development of integrated railway transport services between the two areas and from there to the respective Countries; the investigation of social and economic activities in the two areas potentially interested by the railway service and their re-launch to China and Far East; the exchange of know-how on logistics and intermodality aspects, on handling and shunting activities; the promotion of joint-initiatives to boost transports, trade and economic relations among the economic actors of both regions.

Matteo Gasparato, President of Interporto Quadrante Europa Verona: "Verona is one of the most important European business partners of the Ruhr Region with important daily traffic and this signature will boost traffic between these areas"

## The state of the Art

The Interporto Quadrante Europa of Verona is the first Italian freight village for services and intermodal traffic that run mainly along the Brenner Corridor through a hundred pairs of weekly trains from and to Germany. Quadrante Servizi provides to public and private operators located in the freight village the shunting services. The WHE is a port and railway operator located in Herne in the middle of the Ruhr Area. The CTH Container Terminal Herne is an intermodal terminal located in Herne and a 100% subsidiary of WHE. TX Logistik is one of the largest rail transport companies in Europe with a specific interest on Brenner Axis.

The Interporto Quadrante Europa of Verona and Wanne-Herner Eisenbahn und Hafen are today connected with 6 services per week operated by TX Logistik.

# **Future projects**

Considering that in 2026 the Brenner Basis Tunnel will open to the traffic with an increase of rail capacity along the ScanMed Corridor. the Consorzio ZAI (Interporto Quadrante Europa of Verona Manager) will develop a project of a new freight terminal, allowing the handling of 750m-long trains. The Whe new intermodal terminal has an annual loading capacity of 250,000 units and all services will be well interconnected, for transport or distribution, storage or maintenance.

# What's ahead?

This collaboration is aimed at increasing the frequency of trains between Verona and Herne and developing new rail traffic to/from Eastern Countries including China and Far East. This activity will include the study of integrated services among the two terminals and the involvement of other stakeholders interested in this new route.
